To obtain a successful permit with the CCRA you must:

- 1. High School, Amateur Rodeo, or CPRA Novice Card Holder.
- 2. Pay \$215 permit fee. Preferred method is cash or e-transfer.
- 3. All memberships must be received via email two days prior to the rodeo entry day.
- 4. Any Roughstock competitor that is not currently enrolled in a Canadian post-secondary program is eligible to purchase a Roughstock permit and compete at all of our CCRA regular season rodeos.
- 5. Permit members may not be an event director.
- 6. Permit members cannot have a voting position on the board of executive.
- 7. Permit members are eligible to compete for cash but no hardware prizes during the regular season rodeos.
- 8. Permit members are not eligible to win any season leader awards.
- 9. Must attend 50% of regular season rodeos to be eligible for Canadian College Finals Rodeo.
- 10. Permit members are not eligible to win a Canadian College Finals Rodeo championship or any hardware. Members are allowed to win cash at the finals.
- 11. Permit members must be approved by the executive of the CCRA. A permit member can be fined or have their membership revoked at the discretion of the executive of the CCRA.
- 12. To obtain a permit membership, the individual must be under the age of twenty-one (21) years old as of July 31, 2023. A picture of the members driver license is required with this application.
